B. 4-H Year Completion:

-SD State Extension would like each county to make their own requirements this year.

-The **minimum** requirements for the completion of a typical 4-H year are on page 2 of the B/L Handbook:

- 1. Attend 4 club meetings
- 2. Complete the 4-H Record Book and turn it into the Extension Office by the deadline
- 3. Give a public presentation at the club level or higher
- Complete <u>ONE</u> of the following:

-Show project accomplishment in one or more project areas

-Participate in judging in any project area at the club or county level

- -Participate in a county event or activity
- -Participate in Junior Leadership

-There has been discussion about decreasing the number of attended club meetings to 3 instead of 4 by County Leaders.

-Raye Brown has suggested that sweatshirts or T-shirts be given to 4-Hers who completed their 4-H Year. -Holly Main questioned whether the Awards Committee were planning on reviewing applications for the following awards for the Recognition Event this fall: Leadership, Citizenship, and Key Awards. Michelle May commented that the Key Award designation is determined by the SD Extension, not the county.

-Raye Brown made a motion that 4-Hers must complete 3 of the 4 requirements including 4 meetings for the 4-H Year Completion. Nicole Jones seconded the motion. **6-Yes, 4-No, 1-Abstain**

New Business:

A. End of Year Completion Dates:

-As usual, record books will be due on September 30, 2020 at the end of the 4-H year and Leader Reports will be due to the office by mid-October 2020. The extension office will decide on the specific date and relay it to the club leaders in the near future.

B. 4-H Recognition/Celebration Event:

-Typically, the Recognition/Celebration event is held in early November. -A decision for a date for the upcoming 4-H Recognition/Celebration Event was tabled until our September 15, 2020 meeting by multiple Council members.

C. Youth Livestock Sale - presented by Shawnie Mackaben:

-There are 52 exhibitors that are signed up to participate in the sale

-On July 29, 2020 at 6PM, 4-H members who plan to sell in this auction are to pick up posters for the sale at the St. Onge Livestock.

-Each 4-H youth is asked to bring a dozen cookies and place them in a bag for the sale on July 31, 2020. -Shawnie Mackaben will contact the 4-H Club Leaders to provide them with the names of 4-H youth who will be selling animals at this sale and with the above information.

-The Youth Livestock Sale is on July 31, 2020 at the St. Onge Livestock Auction

-At 6PM, there will be a FREE appreciation BBQ meal and the sale starts at 7PM.

-This sale was established due to the cancellation of the 4-H Livestock Sale.

D. 100th Anniversary of the Fairgrounds:

-The dates are set for July 27-31, 2021

-Amy Clark has asked the Redwater Council for ideas and proposals to take to the Fair Board in the upcoming months.

-Sheryl Pittmon would like to remodel the old Fair Office at the fairgrounds to create a museum or "history house" for next year. If you are interested in supplying materials or helping with a remodel, please contact the extension office. This could be a great club project.

-Due to the recent storms, the fairgrounds have been littered with many tree limbs. The Swine Barn sustained some damage to the roof from a fallen tree branch.

-Clubs are encouraged to clean and inspect their respective buildings that have been assigned to them for clean-up between July 15 - August, 15, 2020. These inspections would help with planning for any maintenance that would need to be accomplished by the Fair Board prior to the 2021 county fair. If your club is planning this activity, call the extension office to ensure the gates are open at the fairgrounds. -County Commissioners would have to be contacted outside the dates of July 15-August 15, 2020 to gain access to the fairgrounds.

-The 100th Anniversary is for the Fairgrounds in 2021, **NOT** the County Fair.

E. SD State Fair - presented by Michelle May:

-The extension office continues to receive more information about activities from the state. These updates will be passed on to the 4-H youth and leaders once it has been received.

-Small animal exhibiting will take place on August 29, 2020. There will be a limit of 2 entries per category. -Seniors do have the option of participating in CDM, Horticulture, and public speaking virtually.

Unfortunately, seniors, who chose this option, would not be eligible to participate in a national trip if they would win or place. This virtual participation will be done prior to the actual State Fair. At this time, dates have not been set and likely won't be known until August.

-Seniors will be the only 4-H youth doing public presentations at the SD State Fair. The juniors and beginners will be virtual through uploading a video.

-There will be much more information for each species and event in the foreseeable future.
