Discussion was held regarding Surety Bond for Buckhorn with the commissioners and Director of Equalization Cristina Wilson. There has been an issue finding a bank that will fill a surety bond. Pioneer Bank is willing to hold a cashier's check in Butte County Treasurer's name or a restricted account in place of a surety bond.

Director of Equalization Cristina Wilson presented a new fee structure to the Commissioners with details on proposed pricing and research conducted on fee structurers for other West river counties.

Ms. Wilson discussed research found after speaking with other counties. The planning department would like to implement an application fee at this time. Ms. Wilson will then take the proposed fee structure to Planning Commission.

Motion Ager Second Erk to approve new fee structure to be implemented in Butte County Equalization and Planning contingent on approval of Planning Commission. Vote Unanimous. Motion Carried

Discussion was held regarding cease & desist letter for 18703 Five Mile Rd. Commissioner Erk asked if anyone confirmed that the property is a junk yard. Commissioner Herman said she has received several calls from property owners.

SA McCartney said the Cease-and-Desist order will give the landowner the opportunity to resolve the issue and meet the requirements of the county ordinance and the DOT. Sheriff Lamphere mentioned that the right of way has been an issue and has been cleaned up as required by SDCL 31-30-1 and SDCL 31-30.

Motion Walton Second Ager to issue a cease & desist letter to owners of 18703 Five Mile Rd with addition of 90 days to initiate compliance with a potential for an extension request if needed after to complete compliance. Vote Unanimous. Motion Carried

Motion Herman Second Erk to approve Final Plat: Owner: Greg Crow; Lots 2A, 2B, and 3, Formerly Lot 2 a subdivision of the SW4SW4, Less Tract A, and a part of the SW4SE4 Located in Section 35, T8N, R2E, B.H.M, Butte County, South Dakota as presented by Planner Cindy Mayes. No preliminary or public hearing required for the plat. Vote Unanimous. Motion Carried

Deputy State's Attorney Edward Tarbay presented the activity report for the department including number of cases resulting from the Rally = 20 cases in 2022 and 21 cases in 2023 with similar types of cases both years, status of criminal and civil cases, grand juries, and jury trials.

Highway Administrator Lori Johnston provided an activity report for the department including blading, mowing, and repair of culverts.

Motion by Erk, Second by Herman to approve DOT Request for Design Exception – Mail Road St# 10-230-310 – Variance in allowable hydraulic design frequency. Vote Unanimous. Motion Carried.

Motion by Walton, Second by Erk to approve Request for Design Exception – Youngberg Road St# 10-340-368 – Variance in design speed from 45MPH to 35MPH. Vote Unanimous. Motion Carried.

Commissioner Erk wanted to thank the highway department for work on Highway 79. Ms. Johnston said the highway there have been calls being received on culverts and work will begin as soon as bridge work is complete.

Sheriff Lamphere provided an activity report for the department. Sheriff Lamphere discussed a case during the rally the county assisted highway patrol on.

Sheriff Lamphere discussed meeting with Elevatus and tour of ShopKo building. Elevatus will draft plans with current building in mind. Elevatus offered to attend a September meeting either in person or via phone. Commissioner Harms asked if there were any discussions about housing all law enforcement personnel in one building. Sheriff Lamphere discussed the shared resources that will make space more efficient and possibility of adding additional departments.

Auditor Annie Capp presented an activity report for the Auditor's Office including upcoming training and meetings related to Incode, Legislation, and Elections. Auditor's office is working on a presentation for the public on Elections.

Motion by Herman Second by Walton to approve the following wage increases presented by Auditor Capp. Vote Unanimous. Motion Carried

- Commissioner Ager was able to contact Brian Leslie about providing audio/video for the commission room. Mr. Leslie is working on a proposal including live streaming meetings on county website.
- Roof of Courthouse has serious damage and will be reassessed by adjuster.
- Air-conditioner in Admin building was discussed. Commissioner Ager will follow up on quotes received and look at additional quotes.

- Auditor Capp to draft a letter to send to Senior Companion group thanking the volunteers for their work.
- Auditor Capp will be scheduling a cyber security test with Project Boundary Fence.
- Department of Transportation meeting to be held Aug 22, 2023, at Community Hall regarding bridge over Belle Fourche River.
- Restructuring of County Health programs was discussed after receiving a letter from Department of Health.
