- -Livestock superintendents will meet with 4-Her's at the extension office to help with Fair Entry at a time to be determined.
- -The Fair Board has requested all changes for each species to be completed prior to the Fair Board meeting in January 2020 for approval the newspaper release in 2020.
- -Mark Heine made a motion to table all Livestock changes for the upcoming Butte-Lawrence County Fair 2020 until our next meeting in January 2020. Raye Brown seconded the motion. **Motion carried.**

### **Animal Registration Deadline:**

-This year, the animal registration deadline for County Fair was July 1, 2019, which was **1 month** after the State Fair Deadline. This was an administrative problem for the office and there was certainly some confusion among 4-H members. Do we keep the late registration deadline or go back to the SD State registration deadline of June 1?

A motion was made by Melissa Dean to leave the animal registration deadline the same as the state deadline which is June 1, 2020. Raye Brown seconded the motion. By show of hands the motion was even with 5 yes and 5 no. A tiebreaker was made by president elect, Amy Clark, to pass the above motion.

### **Universal Livestock T-shirts:** Shannon Davis

-At the Junior Livestock Show in Lemmon, SD, all 4-H kids wore the same t-shirts when showing their animals. Shannon Davis was wondering if this would be something our counties would want to implement for our 4-H Livestock shows. There was discussion about cost/t-shirt, if t-shirts would be provided on an annual or every other year basis, and who would pay for the t-shirts.

After further inquiry, Shannon did not feel that this was worth further discussion and the idea has been dropped.
