B. End of the Year Completion:

-Everyone should have received their leader packets.

-The end of the year completion date for the leader packets is 9/21/2020 at the extension office.

C. 4-H Recognition and Celebration Event:

-Presented by Michelle May

-The 4-H Recognition Event will be very challenging this year due to the Covid-19 pandemic.

-Every year the location changes between Lawrence and Butte County. Lawrence County will be sponsoring the 4-H Recognition Event in 2020.

-Michelle checked with Spearfish HS and this was not an option. Michelle has not heard back from Meier Hall at BHSU or The Barn.

-After extensive research, the extension office decided to have the event at the Pavillion in Spearfish. -The Pavillion costs \$350 dollars with a \$75 dollar deposit.

-October 25, 2020 has been selected as the date of the 4-H Recognition Event due to location availability and responses from families.

-Typically, the Pavillion may seat 350 people, however, with our current guidelines for social distancing from the state, we could have approximately 150 people present with a waiver by the state.

-Kindra Gordon suggested that we consider cancelling the Recognition Event due to the uncertainty of what things will look like with Covid-19 in the next few months and to distribute the commemorative hoodies to 4-Hers who have completed their record books. This would mark the end of the 4-H year. **Many committee members showed their support for this choice.**

-Shawie Mackaben felt that 4-H youth would not be able to enjoy the big recognition event this year with all the restrictions that are required by the state.

-Michelle May had suggested that individual clubs could hold their own Recognition Event.

-Shawnie Mackaben made a motion that each individual club will host their own recognition event and that the annual Butte/Lawrence County Recognition Event be cancelled for 2020. Nicole Jones seconded the motion.

The Jr. Leaders are inquiring about using **some or all** of the \$1700 dollars that was donated by Culver's Restaurant in Spearfish. -The hoodies will cost \$19.00 each.

-Shawnie Mackaben has recommended that we use **all** the \$1700 dollars from the Culver's donation towards paying for the commemorative hoodies.

-Holly Main made a motion to use all of the \$1,700 dollars of the Culver's donation to use toward the cost of commemorative hoodies. Shawnie Mackaben seconded the motion.

-There is one family that plans to participate in the SD State Livestock competition this weekend in

Brookings, SD.

B. New 4-H Year 2021 and Covid-19 Updates:

-Presented by Michelle May

-The Monday Minute from 9/14/2020 provided a summary for Covid-19 requirements by SD State Extension.

-If a 4-H event is being held **indoors**, SD State Extension requires **everyone** to be wearing masks. -If a 4-H event is being held **outdoors**, SD State Extension requires social distancing of at least 6 ft. between individuals. There is a five page document that was provided to 4-H leaders and volunteers discussing these updates.

-There is a **mask exemption** for children 2 years and younger. If there is a psychological or physical condition that would necessitate an exemption, you may contact the extension office via phone or email to discuss a mask exemption. For special situations, 4-H Leaders may contact the office if they would like to advocate for an individual for a mask exemption. Mask exemptions must be approved through the

extension office by Michelle May or Cindy Riley. Cards will be given in person or mailed to individuals for mask exemptions. Personal freedom and political affiliation are not grounds for mask exemption. -Indoor Shooting Sports are required to wear protective masks.

-Please contact the office if you have any further questions or concerns.

C. Dates for the 2021 Butte/Lawrence County Fair:

-The dates are set for July 27-31, 2021

-The 100th Anniversary is for the Fairgrounds in 2021, **NOT** the County Fair.

-Amy Clark has asked the Redwater Council for ideas/themes/ proposals to take to the Fair Board in the upcoming months.

-Kindra Gordon has suggested that each club submit an idea/theme for the county fair by November 1, 2020. Cindy will send out an email to the 4-H Leaders to discuss possible proposals at their next meeting.

D. Youth Mental Health First Aid:

-Youth and Family Services in Rapid City are sponsoring this program.

-This is a training tool to help access if youth are at risk and how best to respond in a crisis situation.

-You need to sign up in advance for this program by September 30, 2020.

-This is an all day event on October 30, 2020 at the Newell School.

E. Miscellaneous:

-Amy Clark has asked that all 4-H Leaders help recruit new members to serve on our multiple and various committees.

-Amy Clark has asked Raye Brown (President of Lawrence County Leaders) and Holly Main (President of Butte County Leaders) to form a nominating committee to make recommendations for our upcoming elections in November 2020.
