No Travel or Abatement Requests

Beginning at 1:06 PM the following citizens appeared during the Public Comment Session:

- Katie Hoffmann commented potential abuse of powers regarding 3J Towing and revocation of Butte County towing rotation. Ms. Hoffmann mentioned the timing of the removal from rotation and concerns that the county did not consider laws the towing company was required to follow. Further concerns were that the company was not allowed on the agenda to speak on this matter and was only allowed to provide public comment.
 - States Attorney McCartney gave background on the case in question. Items mentioned were threats made to the towing company, phone calls between owners' lawyer and States Attorney office, legal responsibilities of owner, States Attorney's office, the courts, and 3JTowing. SA McCartney went on to explain the additional steps taken by the car owner, her representation, the States Attorney office, 3J Towing, and Circuit Court. Judge issued a warrant to release the car contents to the defendant. States Attorney mentioned several inconsistencies between posts on social media and facts. SA McCartney then spoke on what responsibilities lie within her office, the Sheriff's office, and the Court system.
 - Sheriff Lamphere stated that part of his office's job is to process court orders and how the court order in question was served to 3J Towing and an employee's refusal to accept the court order. Owner of 3J Towing provided a refusal in writing to follow the court order resulting in the Sheriff's Office decision to remove the towing company from the rotation until the situation is resolved.
 - Clayton Johnson spoke on the lack of knowledge showing there is a criminal case. SA McCartney shared the case number with 3J Towing. The owner of 3J Towing mentioned the legal requirements they must follow stating they must release items such as clothing, food, and medication. Mr. Johnson asked why it was so hard to find information on the case.
 - Ms. Hoffmann asked if commissioners could review and confirm whether 3J Towing was required to follow the court order or if doing so would cause the company to break laws.

- Rose VanSickle appreciated the interaction with commissioners and the attendees. Ms. VanSickle asked for more information on what and why commissioners approve agenda items. Ms. VanSickle ended by offering all a Happy Thanksgiving.
- Bob VanSickle mentioned minutes regarding executive session held during the last commissioner meeting reminding commissioners that no action is to be taken during executive session. Auditor Capp assured VanSickle that the intention of the wording in the minutes was to reflect no action was taken after the session ended.
- Dale Simanton started by stating he hadn't been to a few meetings, bringing up the
 recent roof quote and the cost of research done on potential of building new courthouse.
 Mr. Simanton suggested that the expense to do research be reimbursed, as it was a
 waste of money.

Motion by Walton, Second by Herman to approve revised Quote 2023-09-22-0908 (update to how the membrane will be adhered) in the amount of \$47,776.30 for Courthouse Roof. Vote Unanimous. Motion Carried

Highway Superintendent Dwayne Heidrich provided an activity report for the department including completed mowing for the year, pulling ditches, fixing roads, and repairing washouts/blowouts.

Sheriff Lamphere provided the monthly activity report.

Sheriff Lamphere provided a summary of recent and Washington D.C. trips including cost to county (minimal), pairing with legislators from Minnesota and an Ohio Sheriff, the group met with State legislators from their states to tell how unsecured borders are affecting their States and Counties. Sheriff Lamphere feels that it is important to stay on top of the issues

Sheriff Lamphere gave an update after he and Commissioner Walton attended the Annual Juvenile Service Center meeting. Butte County was awarded the Most Utilized County award and will be receiving a \$67,000 rebate. Sheriff Lamphere explained the program and the benefits of joining and remaining part of the compact.

Sheriff Lamphere congratulated Deputy Bailee Hahne on her recent graduation from the academy. The open deputy position was offered to someone today.

States Attorney LeEllen McCartney presented the activity report for the department including inmates currently in jail and related charges, November grand jury cases, amount of current open cases is 361, juvenile cases year to date numbers are 107, and summer intern candidate accepted. December 29th,

Auditor Annie Capp presented an activity report for the Auditor's Office including Butte Co. Republican Central Committee Meeting, Administrative Rules Hearing, and end of year activities. End of year special meeting was tentatively scheduled for 29Dec2023.
