Beginning at 9:47 AM opportunity for public comments was opened with Sue Broadhurst providing comments regarding agenda, flowers, supplies, water coolers, invoices, tax increases and spending.

Director of Equalization Cristina Wilson provided a report on Property Assessments - to be sent out by March 1st, 2025, changes made including reappraisals, land values, ag land audit, obsolescence, and value trends. Additional discussion revolved around ag land calculations, equalization process/requirements, and market price.

Sheriff Lamphere provided a monthly activity report – discussion was held regarding livestock calls. The Contract for Housing of Prisoners and Detainees in the Meade County Jail and the Western SD Juvenile Services Rebate were shared with commissioners.

Motion by Batterman, Second by Erk to authorize Sheriff Lamphere to sign the Contract for Housing of Prisoners and Detainees in the Meade County Jail. Vote Unanimous. Motion Carried.

Sheriff Lamphere discussed the need for a transfer Switch – a grant request has been submitted. During the next regular meeting on 04Mar2025 Chief Deputy March will present information on drone program.

Auditor Capp provided an activity report focused on annual report progress and building activities.

Auditor Capp presented multiple options for purchase of Commission Room Chairs from local and outside companies, discussion with City of Belle Fourche and Butte County will be held next week. Follow-up on chairs will be included on the 04Mar2025 agenda with additional options from local sources.

Motion by Erk, Second by Walton to approve for Letter of Support for the SDDOT PROTECT Grant Application. Vote Unanimous. Motion Carried.

Motion by Batterman, Second by Erk to approve Indigent Burial Request in the amount of \$2,000.00. Vote Unanimous. Motion Carried.

Discussion with possible action on courtroom flip and security. Grant is still available with funding provided upfront by the county and a 75% reimbursement from the Courtroom Security Grant. Courtroom Security Project will move forward, beginning with a request for quotes. 04Mar2025 provide original plans, bids, and financing options.

Belle Fourche Chamber Director Mikayla Horn gave an activity report including upcoming lunch and learn 19 Feb 2025, annual banquet 28Feb2025, publications, networking with surrounding chambers, monthly mixers, recent Cracker Barrel, and a potential 2nd cracker barrel.

A 5-minute Recess was called at 10:41AM.

States Attorney Tim Barnaud provided a report on the number of residents in jail. Immigration cases and processes were discussed.
