THE BOARD OF BUTTE COUNTY COMMISSIONERS CONVENED AT 9:30 A.M. on Tuesday, January 21, 2025. Commissioners present were Ager, Erk, Walton, Batterman, and Brunner.

Chair Ager called the meeting to order and led the group in the Pledge of Allegiance.

Chair Ager called for a moment of silence/reflection. Discussion was held regarding changing to time of prayer and reaching out to committee members, the public, and ministerial associations for future meetings.

Larry Dean Department of Transportation was on the phone to answer question regarding FHWA Urban Area Map Belle Fourche Boundary change. Mr. Dean gave some background on the need and process for changes such as this. Population density determines urban vs rural boundary designation and traffic makes determination.

Beginning at 9:45 AM opportunity for public comments was opened with Dale Simanton, Calvin Fickbohm, and Sue Broadhurst providing comments regarding chairman terms and policy, resolution on mandates on electronic tagging, bills for old jail electric, motions, planning board commissioners, chairman election, utilities, Roberts Rules of Order, and Planning Commission title.

Motion by Brunner, Second by Erk, to adopt the 2025 Committee Appointments appointed by Chair Ager. Vote Unanimous. Motion Carried.

Sheriff Lamphere provided a monthly activity report. Lamphere discussed recent purchase of pickup, surplus previous vehicle to highway, and cyber security concerns.

Discussion was held regarding Court Services and the court room "flip". Judge Day gave a background on the project, grant, and HVAC. Judge Day spoke on the need for the flip (safety, needed updates). Additional discussion was held regarding potential for new space and developing plan to have courtroom built as needed. Ager will reach out to city regarding using city chambers.

Court Services had a survey completed and the results of Safety Survey Needs include:

- a) New office main entrance door with a security pass to enter and push button to exit.
- b) A security camera in the lobby for clients sitting in the hallway and another camera inside the Court Services office but only pointing towards the main door entrance.
- c) Office walls for Chanda.

It was decided to obtain quotes for a security door and cameras until more options can be found.

A five-minute recess was called.

Auditor Annie Capp presented an activity report for the Auditor's Office including end-of-year activities, tax bills, and building activities. Auditor Capp mentioned the last five years of statistics for lien recoveries.
