Beginning at 9:50 AM opportunity for public comments was opened with Sue Broadhurst and Dale Simanton providing comments and questions for commissioners to consider. States Attorney McCartney responded to some of the comments made by Ms. Broadhurst.

Butte/Lawrence County 4H Director Melanie Coleman provided an activity report. Ms. Coleman requested permission to use the Fairgrounds for dog training activities and was granted permission after electric upgrade has been completed. Ms. Coleman also commented on upcoming activities.

State's Attorney LeEllen McCartney introduced her summer intern Kolby Lintz and gave an activity report including current cases, upcoming trials, and status of open deputy position.

State's Attorney LeEllen McCartney presented commissioners with termination of contract with Tim Barnaud in preparation for his beginning term as Butte County States Attorney. SA McCartney mentioned there were civil issues that they are also working on in the office such as Tax Deeds and revision of Cannabis Ordinance.

Motion by Harms, Second by Herman to ratify decision to mutually agree to terminate contract for Indigent Defense contract with Timothy Barnaud. Vote Unanimous. Motion Carried. A request for proposal will be sent to determine interest in serving as Butte County Indigent Defense Attorney.

Sheriff Lamphere provided the monthly activity report. SA McCartney mentioned that she recently looked at the ordinance for dogs at large and will be updating the ordinance in a future meeting.

Motion by Herman, Second by Erk to enter into Executive Session for Personnel 1-25-2(1) at 10:12 AM. Vote Unanimous. Motion Carried. Came out of Executive Session at 10:24 AM. No action was taken as a result of executive session.

Auditor Annie Capp presented an activity report for the Auditor's Office including election activities, ballot measures, and SDACO Spring Workshop.

Auditor Capp shared information on the proposed Memorandum of Understanding regarding the upcoming Sentinel Missile Project. States Attorney McCartney expressed concern about open discussion regarding MOU based on potential security issues.

### Committee Reports were given:

- Commissioner Walton said EDC board is focused on railroad and housing activities
- Commissioner Ager has taken calls on roads and mentioned that a summer road plan is in place.
- Auditor Capp gave a recap of the BHACCO meeting on 08May.
