No Travel or Abatement Requests

A plaque was presented to Kenny Mitchell for his years of service in the Butte County Highway department.

Beginning at 1:12 PM the following citizens appeared during the Public Comment Session:

- Sue Broadhurst Ms. Broadhurst mentioned SDCL 1-27-1.16 regarding material not available to public specifically mentioned was the five-year road and bridge plan.
 Planning board meeting materials are also missing from public packets.
- Travis Ismay asked the commissioners if they believed they were above the law. Mr.
 Ismay believes the commissioners have violated county ordinances, state law, and open
 meeting laws. Mr. Ismay referred to GLP Custer renewal application, violating SDCL3420G.77, and wanted to know why their application was approved.
- Katie Hoffman asked, "Where has our money gone?". Ms. Hoffman asked about cost of
 projects, charges against juveniles, truancy programs, and lack of fines issued against
 cannabis establishments. Ms. Hoffmann referred to SDCL7.8.20 further implying there
 has been a lack of maintenance of courthouse and roads over the years. Ms. Hoffmann
 then asked how property taxes were being spent while taxes continue to increase with
 no perceived benefit to taxpayers.

Bruce Wilsey presented the Bridge Inspection Report presented by Brosz Engineering. Eight bridges were inspected. These structures are not in the regular schedule and were considered older structures. Mr. Wilsey said he believes in the ten plus years he has been inspecting structures in Butte County, there have been significant improvements. Additional requirements are now needed and, in some cases, an annual inspection or notice of issues may need to occur. Some of these structures are in the process of receiving or completing BIG grant applications. A full inspection will be completed in 2024.

Michelle May, Director of 4H, thanked the commissioners for all their support throughout her tenure in Lawrence County and Butte County. The commissioners thanked Michelle for her hard

work over the last seven years. When asked about a replacement, Ms. May's said the process has started but the position has not been posted at this time. She also felt the position will not be hard to fill with local candidates and a strong program. Commissioner Herman said there are big shoes to fill.

Chief Deputy March provided the monthly activity report.

Chief Deputy March explained the Motorola Wave App that can be downloaded to any cell phone which then converts the phone to a handheld radio. March would like to offer the app to Fire departments. The fire departments would pay for any signups – price is \$13.00 per user which Butte County will host. Each Fire department will reimburse the county per user or create their own account with Motorola. Since the app is a state channel, users would need to be digital to talk to each other - analog radios are on Civil Defense. Chief Deputy March will offer the app to Fire Departments at their next meeting.

A short recess was called at 2:07 PM. Meeting reconvened at 2:15 PM.

Deputy State's Attorney Edward Tarbay presented the activity report for the department including October grand jury had eight cases going to trial, incarceration numbers and

breakdown of charges, status criminal and civil cases, juvenile cases, and magistrate court. DSA Tarbay stated he currently has over 100 cases.

Deputy SA Tarbay shared information regarding the JJRI program and FY2023 JJRI Fiscal Incentive Diversion Program Payment.

Auditor Annie Capp presented an activity report for the Auditor's Office including SDACWO meeting, Belle Fourche City special election, 2024 election calendar, and post-election audit.

Auditor Capp shared the Delta Dental bus statistics provided by the Butte County Health Services department.

Auditor Capp presented a request by NACo to fund the National Association of Counties (NACo) initiative to establish the National Center for Public Land Counties. NACo is requesting 1% of LATCF funds received by Butte County for a total amount of \$5,124.93. No action was taken.

Committee Reports were given:

- Herman Black Hills Council of Local Governments coming up.
- Walton researched cost of chairs for commissioners and commissioners' assistant chairs. Cost provided for two options. No action taken. Weed and Pest meeting held.
- Ager planning meeting was held last week with everything completed in today's meeting.
